(The London Marathon Company operates a black-listing policy for Gold Bond place holders who default on their commitment to their chosen charity.)
- 3) All entrants will be notified of the outcome of their application by the start of October 2011. Some places may be awarded before this date.
- 4) You must inform us of any injuries or any other reason why you would be unable to take part as soon as possible.
- 5) You must inform us of the result of your application to the Ballot.
- 6) You do not need to send any money now. If we are able to offer you a place, we will ask you to provide a £50 entry fee, this can be paid for by cheque or over the phone with a debit or credit card.
